He has joint custody of three young children and is able to see them on the weekends. He has been consistently employed and is a hard worker, however his paycheck is virtually gone after paying child support, his bills, food and gas.

He lives a very modest life, belongs to a community church and tries to be the best father he can be for the short time that he has his children.

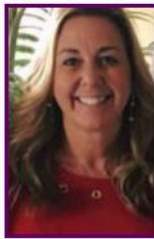
To help with his tight budget, Love INC referred him to FISH, and he regularly uses our clothes closet, home goods and personal care ministries. We've delivered food boxes to his home on occasion, have given him food and gas cards and more recently have helped with a car repair. At Christmas, our client was referred to a neighboring church for gifts and to Bed, Blessings and Beyond for a Christmas tree.

In addition to providing area resources and financial support, Love INC staff and volunteers have been available to provide emotional support and prayer.


